The application form for admission into the 3 year LL.B. 1<sup>st</sup> semester for the session 2023-24 will be available on SAMARTH portal. Application form will be available in the SARARTH portal and interested candidates will have to submit the application form in that portal along with required supporting documents.

Admission shall be made on the basis of a MCQ based entrance test which will include tests of linguistic ability, Analytical skill, and level of quantum of information, Mathematical, Legal reasoning and aptitude of learning law.

Eligibility Criteria for three year LL.B. Course.

An applicant who has graduated in any discipline of knowledge from a University established by an Act of Parliament or by a State legislature or an equivalent national Institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University with minimum of

45% marks General category candidates.

40% marks for SC/ST candidates.

42% marks for OBC/ MOBC candidates.

The entrance test shall be conducted for all the applicants. Candidates need to pay entrance test fee for entrance test in the payment link to be provided in the SAMARTH portal. Students will have to submit payment receipt at the time of collecting Admit card on 19/08/2023 and 21/08/2023.

The details regarding the admission procedure shall be available at SAMARTH portal. Incomplete/ incorrect forms and forms without proper documents will be rejected.
