The application form for admission in to the 5 year integrated B.A. LL.B. 1st semester for the session 2024-25 will be available on Samarth portal from 19-06-2024. Interested students can apply online and upload the requisite supporting documents to the SAMARTH PORTAL (<https://brmlawcollegeadmission.samarth.edu.in/>)

Admission shall be made on the basis of an entrance test comprising of descriptive question **[50 Marks]** and MCQ **(50 Marks)** which will include tests of linguistic ability, Analytical skill, and level of quantum of information, Mathematical, Legal reasoning and aptitude of learning law.

Eligibility Criteria for 5 year integrated B.A. LL.B. Course.

An applicant who has successfully completed Senior Secondary school course (+2) or equivalent from a recognized university of India or outside or from a senior Secondary Board or equivalent, constituted or recognized by the union or by a State Government or from any equivalent, Institution from a foreign country recognized by the government of that country for the purpose of issue of qualifying certificate on successful completion of the course with a minimum of

45% marks for General category candidates.

40% marks for SC/ST candidates.

42% marks for OBC/ MOBC candidates.

The entrance test shall be conducted for all the applicants. Candidates need to pay Rs 500/- (Rupees five hundred) only for entrance test.

For the details regarding the admission procedure shall be available at SAMARTH portal. Incomplete/ incorrect forms and forms without proper documents will be rejected. Candidates are expected to keep themselves updated with the notification uploaded in www.brimgovtlawcollegegy.org. from time to time.
