The application form for admission in to the 3 year LL.B. 1st semester for the session 2024-25 will be available on Samarth portal from **18-07-24**. Interested students can apply online and upload the requisite supporting documents to the SAMARTH PORTAL- (<https://brmlawcollegeadmission.samarth.edu.in/>)

Admission shall be made on the basis of an entrance test comprising of descriptive question **(50 Marks)** and MCQ **(50 Marks)** which will include tests of linguistic ability, Analytical skill, and level of quantum of information, Mathematical, Legal reasoning and aptitude of learning law.

Eligibility Criteria for three year LL.B. Course.

An applicant who has graduated in any discipline of knowledge from a University established by an Act of Parliament or by a State legislature or an equivalent national Institution recognized as a Deemed to be University or Foreign University recognized as equivalent to the status of an Indian University with minimum of

- 45% marks General category candidates.
- 40% marks for SC/ST candidates.
- 42% marks for OBC/ MOBC candidates.

The entrance test shall be conducted for all the applicants. Candidates need to pay Rs 500/- (Rupees five hundred) for entrance test. The candidates waiting for final year results of the degree examination held in this year can also apply and if qualified in the entrance test, the candidate will be allowed to take provisional admission with the condition that the candidate shall have to pass the degree examination and if the candidate fails in the degree examination the provisional admission shall be cancelled without any condition.

The details regarding the admission procedure shall be available at Samarth portal. Incomplete/ incorrect forms and forms without proper documents will be rejected.
